Summary of Academic Achievements

Full Professor for over 18 years. Department Chair for over 17 years. Hired in 2021 as a Full Professor and Department Chair of the Administration & Law Department at the University of West Florida. Promoted in 2023 to Assistant Dean of the College of Business. Promoted again in 2024 to Associate Dean for Academics and Accreditation. Retired from the University of New Haven in 2021. Awarded Professor Emeritus in 2023. Was responsible at UNH for coordinating the largest program in the College of Business (COB) which generated significant fiscal results with a limited faculty and close to 200 students in the program. Implemented assurance of learning efforts and sport management received exceptional acknowledgment from the AACSB review team. Was responsible at UNH for creating various programs such as several MS degrees, the first STEM based sport analytics program in the United States, mentor programs, advisory boards, and other initiatives. In 2019 helped create the first esport degree program in and AACSB accredited school, helped create a campus wide esports degree across multiple colleges, and helped hire an esports coach, esports faculty member, and worked with architects/builders to create an esports lounge which opened in 2020. Awarded several lifetime achievement awards in sport law and sport management.

Was a practicing litigation attorney back in the 1990s. Started working as an expert witness in 1993 and since then have served as an expert in over 260 cases all over the United States. These cases have included cases involving testimony at some of the biggest sport/risk management injury cases over the past 25 years. Serve as a consultant for various sport organizations and serve on the advisory board for the nation's largest specialty netting company. Edit the industry's primary sport facility law publication (Sports Facilities and the Law), write a regular column for the IAVM's Facility Manager publication called The Facility Doctors, and wrote the IAVM's initial Academy of Venue Safety and Security (AVSS) textbook.
